3. Ibisabwa k'ushaka kuba umunyamuryango

Reg. 2018/848 Article 36



Umubare w'abanyamuryango

Hano hari ibisabwa bishya ku banyamuryango b'amatsinda. Abagize itsinda bakwiye:

- » Kuba bafite ubutaka butarengeje hegitari 5, cyangwa igice cya hegitari (0.5 ha) mu nzu (greenhouse); cyangwa se hegitari 15 z'umurima uri ahan-tu hisanzuye. Ubutaka buvugwa bugizwe n'imirima y'umuhinzi yaba iyemewe cyanga itemewe.

» Kuba bafite ibicuruzwa bituruka ku buhinzi bifite agaciro katarenze ayarero (EUR) 25.000 hamwe n'icyemezo cy'umuhinzi kitarengeje 2% by'agaciro k'ibikomoka ku buhinzi bw'umwimerere. Kubera ko ari ibisanzwe ko agaciro k'icyemezo cy'ubuhinzi karenga amayero 500 € (bingana na 2% by'umusaruro wemerewe kugurishwa atarenze amayero 25.000 EUR), agaciro k'ibicuruzwa niko gipimo gifatika.

Ibi bivuze ko abahinzi bafite hegitari zirenga 5 z'ubutaka bwo guhinga bashobora kuba abanyamuryango b'itsinda mu gihe agaciro k'ibi-curuzwa by'umwimerere kari munsi yamayero 25.000 EUR.

Hamwe n'amabwiriza mashya, inzego zishinzwe kugenzura zigomba guhindura "iyuhirizwa ry'amategeko n'amabwiriza" kugira ngo hatangwe icyemezo cy'ubuhinzi bw'umwimerere mu bihugu bikiri mu nzira y'amajyabere.

Hariho igihe cy'inzibacyuho cyasobanu-we kugirango inzego zishinzwe kugenzura zongere ibyemezo kandi zuzuze ihame rishya ryo kubahiriza ibisabwa kugeza mu mpera za 2024. Inzego zishinzwe kugenzura zishobo-ra gukora igenzura hakurikijwe amabwiriza mashya ari uko barangije iki gikorwa.

Ubuzimagatozi busobanura iki?

Ubuzimagatozi ntabwo busobanura mu mabwiriza. Dutekereza ko itsinda rifite ubuzimagatozi rishobora kuba koperative iyo ari yo yose, ishyirahamwe ry'abahinzi, sosiyyete sivire n'abandi. Mushobora gushaka amakuru k'ubwoko bwemewe bw'ubuzima gatozi bushoboka mu gihugu cyanyu n'ibisabwa bigomba kuzuzwa kugira ngo mwandikisha itsinda rifite ubuzimagatozi.

Dufite abanyamuryango barenga 2000 bemewe, dukwiye gukora iki?

Ariko, ni ngombwa gushakisha uburyo bukwiye bwo gushyiraho uburyo bwiza bwo kwigenzura (ICS).

Icyemezo cy'itsinda gishobora gutangwa ku matsinda agizwe gusa n'abanyamuryango b'abahinzi. Ku bw'ibyo, abahinzi bafite amasezerano bagomba gushyirwa mu matsinda yigenga, bariyandikishije bafite ubuzima gatozi kandi baremejwe mu buryo butandukanye na sosiyete itunganya umusaruro. Ni ngombwa gushakisha uburyo bukwiye bwo gushyiraho imikorere y'urwego rwacu rwigenzura (ICS) mu gucunga itsinda rishya ry'abahinzi. Urugero, urwego rushinzwe igenzura (ICS) rushobora kubamo itsinda ry'abahinzi. Ubundi, ubuyobozi bwa ICS bushobora gukorana na sosiyete itunganya umusaruro. Byongeye kandi, itsinda rishya ry'abahinzi rishobora kugirana amasezerano yo kugurisha ibicuruzwa muri sosiyete itunganya umusaruro.

Agaciro k'umusaruro w'umwimerere ni iki?

Umusaruro ngarukamwaka n'amafaranga yose umuhinzi yabonye aturutse mu kugurisha umusaruro w'umwimerere muri (ICS). Ubarwa mu buryo bukurikira: **gufata umusaruro w'umwaka wose (ukagabanya)/ ikigereranyo cy'umusaruro ukubye n'igiciro ku kilo kimwe.** Mushobora kureba icyitegererezero cyo kubara muri iyinyandiko

Ni ryari dukeneye kubahiriza ibisabwa bishya?

*Ibi biterwa n'urwego rw'ibihugu by'ubumwe by'uburayi rushinzwe igenzura. Inzego zishinzwe kugenzura zizashyira mu bikorwa ubugenzi hakurikijwe amabwiriza mashya nyuma yo kongera kwemererwa gukora. **Iyi gahunda yo kongera kwemererwa igomba kurangira ku ya 31 Ukuboza 2024 nibura,** bityo rero hafatwa ko iyubahirizwa ry'amatsinda y'abahinzi ku mabwiriza mashya azasuzumwa mu gihe cy'igenzura rya 2023 cyangwa 2024. Mushobora kuvugana n'urwego rw'ibi-hugu by'ubumwe by'uburayi rushinzwe igenzura kugira ngo rubahe amakuru y'innyongera*

Naturland iri gushyira mu bikorwa umushinga witwa "Partner Afrika" ku bufatanye na ROAM (Rwanda Organic Agriculture Movement) hitawe cyane ku itsinda ry'abagore ryitwa "Ejo Heza" ribarizwa muri koperative KOPAKAMA (Akarere ka Karongi, Rwanda).
