EU Deforestation Regulation (EUDR)



In the EU, commodities such as timber, coffee, cocoa, palm oil, cattle, soy bean and rubber shall only be placed on the market if

- they are free of deforestation (as of 31 December 2020).
- they are produced in accordance with the relevant legislation of the country of origin
- are covered by a declaration of due diligence.

This also includes derivatives such as palm nuts, glycerine, palmitic acid, stearic acid, carboxylic acids.....Chocolate, cocoa shells....

Also applies to products on the EU market

Naturland - Most affected crops outside the EU



Coffee Latin America: Honduras, Mexico, Nicaragua, Peru

Naturland Survey July 2024 Outcome

- Knowledge about EUDR
- one third of the Naturland members answering the survey already had a high level of knowledge
- another third knew more or less about the regulation
- there was no one who was not at all familiar with the subject
- GPS Data
- 85% of survey participants have already started to collect the geographical coordinates of the production plots
- Support required
- 93% need support



Naturland Survey July 2024 Outcome



Almost everybody required ongoing support through detailed training on data collection, plotting and validation of the EUDR:

- In general, better understanding of the EUDR requirements and how to implement the necessary measures to comply.
- Some needed financial support, e.g. to acquire more accurate equipment for data collection such as smartphones, to facilitate travel, or to pay data collection agents.
- Some participants asked for help with the Due Diligence Statement.

Naturland partner level:



- Partners are in dialogue with the producers; data is supplied but is only partially usable, often incomplete, etc.
- Coffee sector works with various service providers to prepare the Due Diligence Statement.
- Partners are making good progress and are pursuing the goal of being able to implement the EUDR as soon as possible; or only buy from producers who are already in the process of implementation.

Challenges regarding data collection



- False positives from public data open sources: Agroforestry systems with coffee or cocoa classified as natural forests
- Indigenous rights/protected area alerts: e.g. coffee is produced in area with indigenous people but they are the ones producing the coffee
- Geolocation data collection has not yet started => lack of cellphones and human resources
- Data quality Geo Json format required to be upload in the European data base Traces
